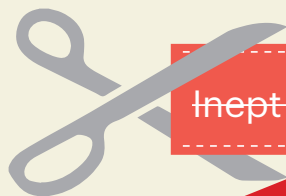

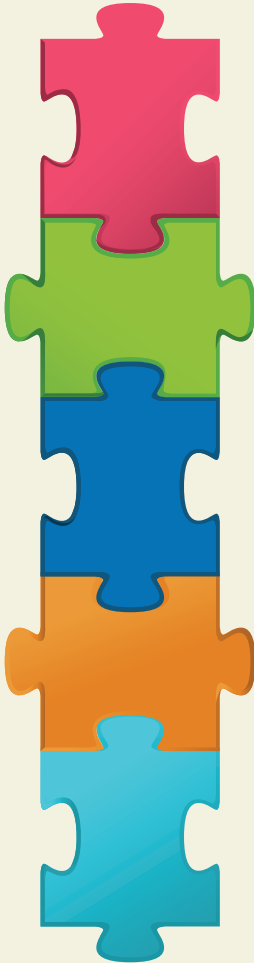
### Verification and Confirmation by LBSL

Required fund availability will be checked by LBSL officials before submitting IPO application.

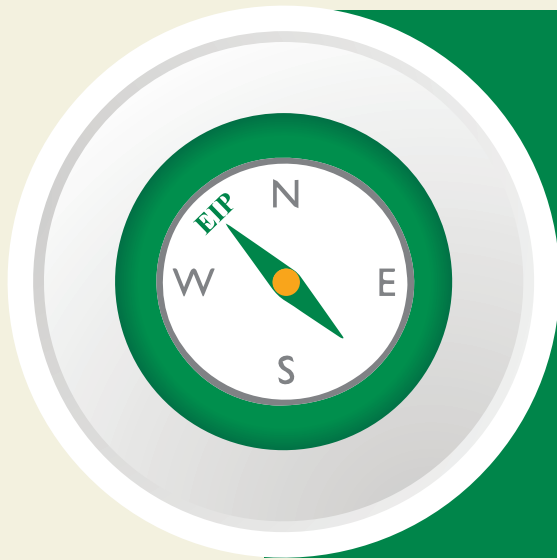

# LBSL Easy Investment Plan (EIP)



Regardless of age, income and experience, like a deposit pension scheme Easy Investment Plan (EIP) facilitates a simple and more convenient way of investing in the stock market.

## What exactly is EIP?

- An EIP is a specific amount, invested at regular intervals for a certain horizon e.g. two/three/four/five years.
- It allows the investor to buy securities as per a pre-decided frequency; the investor has the complete discretion to decide the amount and also the stock to invest in.
- EIP utilizes the time-tested methodology of BDT cost-averaging method, which allows an investor to minimize risk and to maximize the return for investment as more number of shares is bought in a falling market and fewer shares are bought in a rising market.

## Benefits of EIP

### EIP Reduces the risk of market timing

It is said that while an amateur goes broke by taking larger losses, a professional goes broke by taking small profit. It is the most prevalent behavioral bias of an investor to be swayed by market mania.

Though it is not impossible, market timing is very difficult task. But the beauty of cost averaging is an automatic market-timing mechanism that eliminates the need to time one's investments. By purchasing shares of stock in small amounts over time rather than one in larger lump sum, you reduce the volatile swings in the market price. Stocks are vulnerable to systematic risk but EIP minimizes the effects of investing in volatile markets.

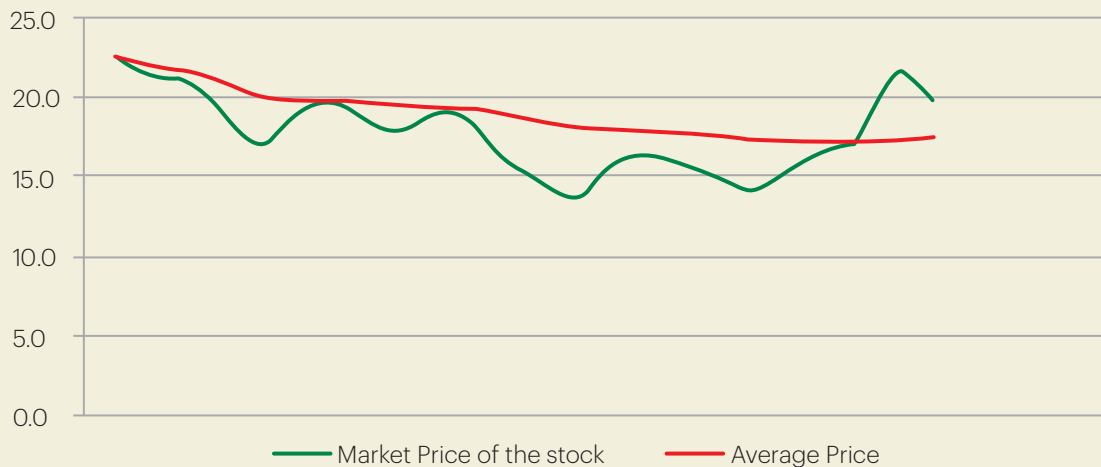
Note: this is an example of a bank stock listed in DSE for illustration purpose only. It is not a solicitation for investment. An illustration next page explains the benefit of an EIP over a lump sum.

An EIP means that one commits himself to invest a fixed amount every month. Let's say it is BDT 15000. When the market price of shares fall, the investor benefits by purchasing more units and is protected by purchasing less when the price rises. Thus the average cost of units is always closer to the lower end making the investment profitable.

Hence, at the end of the period total units purchased will be 15,949 & cost per unit will be BDT 22.6. Thus, the loss from the above investment will amount to BDT 41013/- (BDT 360000 – BDT 318987) or 11% loss.

Thus, EIP minimizes the effects of investing in volatile markets. It helps you average out the cost by generating superior returns in the long run. It reduces the risk associated with lump sum investments.

**EIP averages out the cost and ensures the benefit at 'optimum point of pessimism'.**

The rebate is applicable on the total value of the tax payable by any individual. For example, if the total taxable income of an individual is BDT 720, 000; he is subject to paying BDT 60, 000 taxes. If the individual invests BDT 216, 000 in stocks, he will be entitled to enjoy BDT 30, 000 tax rebates. The calculations are shown in the following table;

## Terms & Conditions

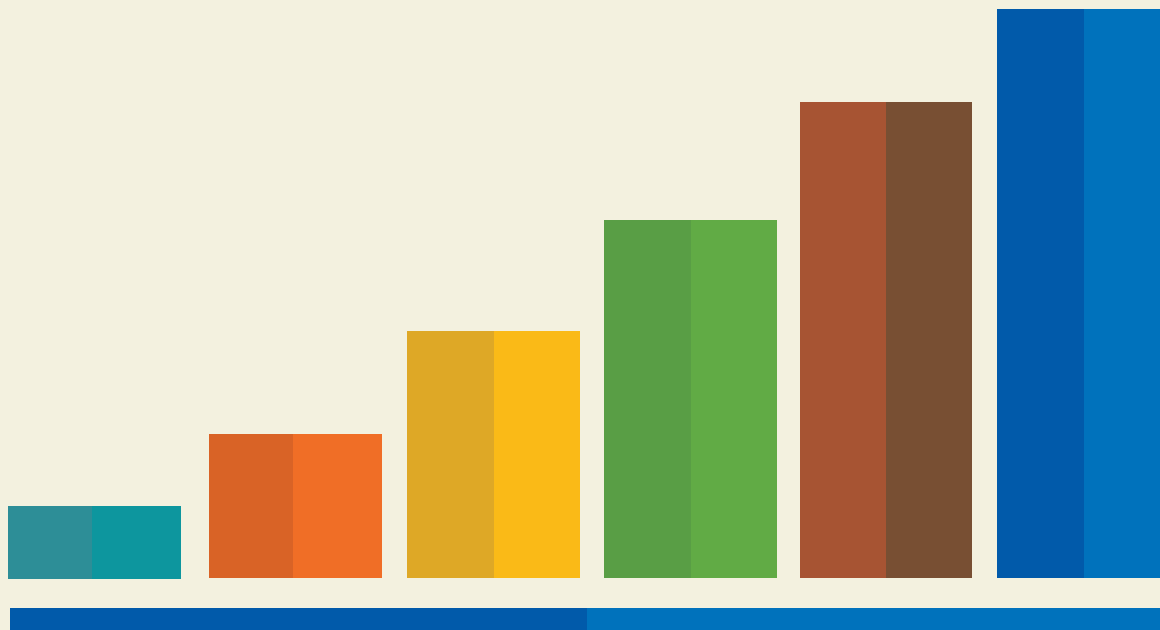

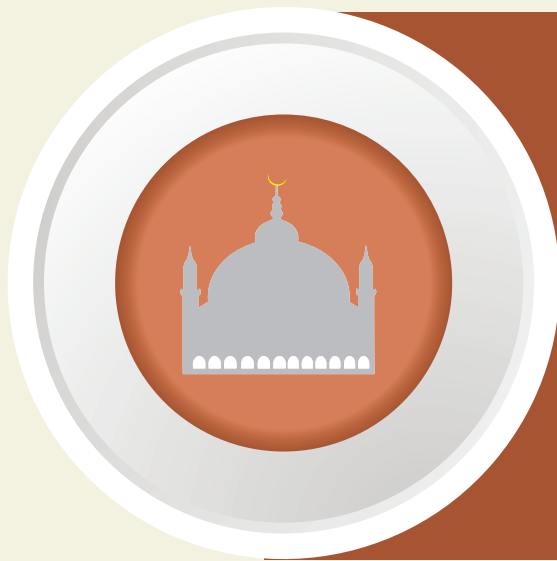

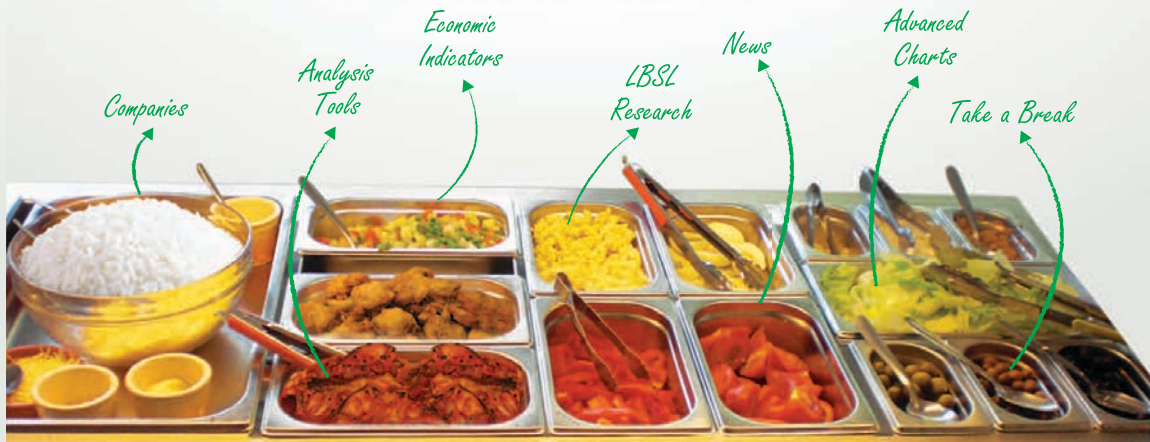
